- **Installation payments available for ALL packages via credit card:** 1st payment due at sign-up, remainder of balance due over 30 day billing cycle increments.
- **Waiver** - All athletes must have a signed waiver (by parent or legal guardian) on file with House of Speed prior to any training. A copy can be obtained from the owner or any trainer and the form must be filled out in its entirety. Any athlete with a medical condition or injury must provide a doctor's clearance before being allowed to participate.
- **Payment** - Fees for any training and payment for any training is expected prior to time of service. No unpaid athletes will be allowed to participate in training.
- **Attentiveness** - Athletes must be able to comply with the requests of the instructor. While some athletes may be excused from certain exercises, they should never interfere with a class drill, program or routine. No cell phones or i-Pod's allowed during training.
- **Equipment** - Athletes should not bring their own equipment into a facility. House of Speed Youngstown will supply all necessary equipment for training or make arrangements with the facility to utilize existing equipment.

TRAINING RULES

- 1) No food or drink (except water in a sport bottle) allowed in facility during training.
- 2) All parents / guardians are to stay clear of training and not to interfere with training. All issues can be addressed after training with trainer or by calling owner at any time.
- 3) Proper workout attire should be worn for all training sessions. Wide-leg or short shorts are not recommended, as they can pose a distraction. No street shoes are permitted in a workout area and the proper cross-training athletic shoes should be worn for training sessions. No t-shirts or any other attire is allowed to be worn by an athlete that is perceived as profane or suggests any rude or sexual connotation.
- 4) No loitering is allowed outside of any facility
- 5) Theft of any equipment will not be tolerated and offenders will be prosecuted accordingly.
- 6) All gym bags should be stored away from training area.
- 7) The use of cigarettes or other tobacco products, alcohol, or illegal drugs of any sort will not be tolerated.
- 8) No spitting on floor or in any drinking fountains or sinks will be permitted. If you need to spit or vomit, please use wastebaskets or toilets.
- 9) No profanity, lewd comments or sexual harassment will be tolerated.
- 10) No horseplay or inappropriate conduct is permitted. Inappropriate behavior includes, but is not limited to threats, verbal abuse, or physical violence.
